

# Privacy Policy

Thanks for participating in the Junior Slam Series! Here we describe how we collect, use and handle your information when you use our website and services.

## What & Why

We collect and use the following information to provide, improve and protect our Services:

*Account.* We collect, and associate with your account, information like your name, email address, phone number, team name, home curling club and player's age, and coach's Ontario Curling Council Coaching NCCP number. We collect, electronically scan and store your team signatures via our waiver and participation agreement. We do NOT collect your banking information, passwords, date of birth or social insurance number.

*Services.* Our Services are designed to make it simple for you to register for a Junior Slam or a ROCKTalk, follow your team's draw schedule and game scores on our LiveScores system, and participate in our sponsor-based athlete, team and coaching rewards program. To make that possible, we store, process and utilize the information you give us. This makes it easier for us to administer our events and our rewards program and to customize the information we send you about the Junior Slam Series.

*Usage.* We collect information from and about the devices you use to access our Services. This includes things like IP addresses and identifiers associated with your devices. Your devices (depending on their settings) may also transmit location information to the Services.

## With whom

We WON'T sell information you provide to us with advertisers or other third parties. From time to time we may share information with others working for Junior Slam Series as described below.

*Others working for Junior Slam Series.* Junior Slam Series uses certain trusted third parties (for example, Curl Coach providers of our LiveScores and IT services) to help us provide, improve, protect, and promote our Services. These third parties will access your information only to perform tasks on our behalf in compliance with this Privacy Policy, and we'll remain responsible for their handling of your information per our instructions.

Our Services display information like your team name, player's names, home club or location and pictures of your team taken at our Slams. This helps us show others images from our Series and compel them to join, sponsor and promote our Services. We do NOT display email addresses or phone numbers.

*Other applications.* You may link to other services from our website, for example linking to our sponsors' websites, or linking to LiveStones by Curl Coach to stream your charted games. When you do so, you give these third parties access to your information. Just remember that their use of your information will be governed by their privacy policies and terms.

*Law & Order.* We may disclose your information to third parties if we determine that such disclosure is reasonably necessary to (a) comply with the law; (b) protect any person from death or serious bodily injury; (c) prevent fraud or abuse of Junior Slam Series, our sponsors or other users; or (d) protect Junior Slam Series' property rights.

Stewardship of your data is critical to us and a responsibility that we embrace. We believe that our users' data should receive the same legal protections regardless of whether it's stored on our services or on their home computer's hard drive. We abide by the Canadian [PIPEDA: Personal Information Protection and Electronic Documents Act](#) for our users' data:

- Be transparent,
- Fight blanket requests,
- Protect all users and
- Provide trusted services.

## How

*Security.* We have a senior data specialist keeping your information secure, backing up and testing for vulnerabilities. We also continue to work on features to keep your information safe.

*Retention.* We'll retain information you store on our Services for as long as we need it to provide you the Services. If you delete your account, we'll also delete this information. But please note: (1) there might be some latency in deleting this information from our servers and back-up storage; and (2) we may retain this information if necessary to comply with our legal obligations.

## Where

To provide you with the Services, we store and process information only in Canada.

## Changes

If we are involved in a reorganization, merger, acquisition or sale of our assets, your information may be transferred as part of that deal. We will notify you (for example, via a

message to the email address associated with your account) of any such deal and outline your choices in that event.

We may revise this Privacy Policy from time to time, and will post the most current version on our website. If a revision meaningfully reduces your rights, we will notify you.
